



Checklist Indian Business Visa – Visa Handling Service Fast Track

Please see to follow a list of documents required to apply for an Indian Business Visa Fast Track:

- Please note that visa requirements are subject to change at short notice and contractors are advised to contact our Visa Administrators to confirm before sending documentation through.
- Also, please contact us for information if you are not applying with a UK passport.
- Please note, **to be able to apply in Edinburgh applicants must provide a Scottish address.**

What we need from you... in Edinburgh

- Passport** (in good condition, with at least 2 blank pages and valid for 6 months after visa expires)
- two 2 inch x 2 inch coloured passport picture**
- Letter of introduction, original from UK company**
(explaining nature of business and duration of visit)
- Letter of invitation from Indian company** (original, printed on official company letter headed paper clearly stating the purpose and duration for which visa is requested)
- Visa Application Form (which must be completed online and can be downloaded here**

- Visa Handling Fee**

What we need from you...in London

- Passport** (in good condition, with at least 2 blank pages and valid for 6 months after visa expires)
- two 2 inch x 2 inch coloured passport picture**
- 2 Letters of introduction, original from UK company**
(1 explaining nature of business and duration of visit, the 2nd explaining the urgency, why fast track processing is required)
- 2 Letter of invitation from Indian company** (original, printed on official company letter headed paper clearly stating the purpose and duration for which visa is requested; the 2nd letter must again outline the urgency and why the fast track option is required)
- Visa Application Form (which must be completed online and can be downloaded here**
